Stand with 1,000 Missourians for equal rights. Help put Virginia Minor's bust in the Hall of Famous Missourians.*

Virginia Minor led the fight for women's suffrage in Missouri. In 1982 she led hundreds of women in an effort to get women the right to vote under the 14th Amendment. With her husband as her lawyer, she sued; but the Supreme Court, in *Minor v. Happersett*, decided that women were not covered by the 14th Amendment's guarantee of equal citizenship for all Americans. Not until 1971, nearly 100 years later, did the Court finally apply the 14th Amendment to women. After losing the case, she studied law and continued her work for women's suffrage until her death in 1894.

AAUW Dues Time:

Your 2013-2014 AAUW membership expires on June 30, 2014. You may renew your national, state, and branch dues in one of two ways.

The preferred way is by credit card paid directly to AAUW at http://www.aauw.org/. You will receive an immediate receipt. At the website, scroll down to "Member Services Database" (MSD) and follow directions to enter (you will need your member number and your special password). If you have never visited the MSD, follow directions to "register." Enter the MSD, click on "renew my membership" on the left, and follow directions to pay.

For the 2014-2015 year, AAUW will distribute \$3.7 million to 245 women for graduate and post-graduate studies.

AAUW Quick Facts: Common Core Standards

The American Association of University Women believes that quality public education is the foundation of a democratic society. AAUW is committed to ensuring strong academic principles and bias-free public education that closes the achievement gap for all children.

AAUW strongly supports high-quality public education for all students. All students should graduate high school ready to succeed in their next steps. AAUW supports states' voluntary adoption of Common Core standards. If states choose not to adopt these official standards, AAUW urges them to adopt similarly robust and comprehensive standards. All students deserve a world-class education, no matter where they live.

<u>What is Common Core</u>? The Common Core State Standards Initiative ("Common Core") is a state-led, voluntary effort that established a single set of educational standards for K-12 in English and mathematics. The standards are designed to ensure that students graduating from high school are prepared to enter college programs or the workforce.

The standards establish what students need to learn, but they do not dictate how teachers should teach. Teachers continue to devise lesson plans and tailor instruction to the individual needs of the students in their classrooms.

Origins and Current Status: The National Governors Association (NGA) and the Council of Chief State School Officers (CCSSO) developed Common Core and continue to lead the initiative. Teachers, parents, school administrators, and experts from across the country, together with state leaders, provided input into the development of the standards.

The federal government had no role in the development of the Common Core and has no role in its implementation. The initiative is a state-led effort, and adoption of the standards is in no way mandatory.

Forty-five states, the District of Columbia, four territories, and the Department of Defense Education Activity have adopted these standards.

<u>Common Criticisms</u>: Critics of Common Core have called it a "federal takeover" and "bad for teachers and parents." Much of the criticism stems from the myth that Common Core mandates that states adopt a set curriculum. States are not required to adopt Common Cores. If a state does adopt Common Core, its schools are able to design their own teaching to meet the standards.

Legal Advocacy Update

Supreme Court Upholds State Ban on Affirmative Action Policies: In April the U.S. Supreme Court released its decision in Schuette v. Coalition to Defend Affirmative Action, a case previewed during our Supreme Court member call last October. The 6-2 ruling upheld a 2006 Michigan ballot initiative that amended the state constitution to prohibit affirmative action admissions at state universities. At issue was not the constitutionality of affirmative action policies but whether the ballot initiative was constitutional. AAUW signed on to an amicus brief urging the court to strike down the ban.

While AAUW is disappointed in it, the ruling does not affect affirmative action policies currently in place in other states. In fact a joint statement issued by the U.S. Departments of Education and Justice on May 6 declared that the ruling leaves "intact the court's prior holdings, recognizing that institutions of higher education and elementary and secondary schools may use all legally permissible methods to achieve their diversity goals." AAUW strongly supports affirmative action policies and will continue to resist similar bans in other states.

Washington Update

Senate Roundtable Addresses Campus Sexual Assault: On Monday, Sen. Claire McCaskill (D-MO) convened the second of three roundtables focusing on how Title IX enforcement can help fight campus sexual assault. Panelists included AAUW's Government Relations Manager Anne Hedgepeth and representatives from the Department's Civil Rights Division, campus administrators, Title IX coordinators, legal advocates, and students. The discussion highlighted the necessity of each university to develop Title IX-compliant campus policies and strengthen enforcement through increased training, transparency and data collection. As Hedgepeth noted, "At the end of the day, getting the information that we create to schools is key," reinforcing the need for well-trained Title IX coordinators and student access to supportive services on campus. The Senate Roundtable is available on C-SPAN.

AAUW Cheer: In the lead-up to a floor debate on Sen. Elizabeth Warren's (D-MA) student loan debt refinancing bill, several senators this week referenced <u>Graduating to a Pay Gap</u>, **AAUW's 2012 research** on the gender pay gap and student debt. Citing AAUW, Sen. Dianne Feinstein (D-CA) said women are hit by a "double whammy" when trying to repay their loans because college-educated women earn on average 82 cents for every dollar paid to men. The Consumer Financial Protection Bureau **also cited AAUW's report** in their testimony on student debt in a Senate Budget committee hearing on Wednesday.

AAUW Jeer: Despite the Senate's confirming the majority of President Barack Obama's judicial nominees, including more than 40 in the last six months, 38 judicial vacancies still remain without a nominee. These delays cannot be tolerated. Not only can the federal courts be a shield for civil rights laws like Title IX and the Equal Pay Act, but they're also often the

last, best hope for women who have experienced discrimination in education, employment, health care, and other aspects of their lives. A strong judiciary is critical to American women.

AAUW Cheer: On May 22nd, the Illinois Senate passed a resolution ratifying the Equal Rights Amendment! Congratulations to the AAUW-IL members who have been working on this issue all year as a part of their joint Impact Grant with Missouri. AAUW-IL mobilized quickly when the bill was scheduled for a Senate committee hearing (held the day before floor passage by the full Senate) by sending out an action alert resulting in more than 300 messages to senators — and more than one-third of the messages were sent within two hours of the alert going out! This morning, they sent another action alert directed at the Illinois House, with the hopes that the House will consider the ERA before the legislative session ends next week.

AAUW supports congressional legislation that would remove the deadline for states to ratify the ERA. Once the deadline is lifted, only three more states need to ratify the amendment for it to become law – and as you can see, Illinois is getting close! Tell your federal elected officials to support this legislation today!

AAUW Jeer: Florida Rep. Charles Van Zant (R) asserted that Common Core standards will cause children to "become as homosexual as they possibly can." Although the comments were recently discovered on video, they originated from his speech in March at an education conference. Glenn Beck echoed the sentiment by comparing Common Core to slavery.

AAUW supports the Common Core standards and is disappointed to hear opponents – and elected officials, no less – making unfounded and offensive statements about this state-led effort to better prepare our nation's students to succeed.

Bits and Pieces

- The National Institutes of Health announced on May 21st that clinical trials must include female laboratory rats. The new guideline intends to eliminate gender bias from scientific research. The lack of a female variable in lab studies has led to adverse drug effects on women after products have been released, a harm which the NIH seeks to mitigate.
- In May the U.S. Senate confirmed Diane Humetewa, the first Native American woman to ever serve as a U.S. District Court judge. Justice Humetewa, a Hopi Indian, previously served as U.S. attorney for the District of Arizona.
- On May 22nd, the U.S. House of Representatives passed the National Defense Authorization Act by a 325-98 vote. The House excluded amendments such as Rep. Jackie Speier's (D-CA) which addressed the way military sexual assault would be prosecuted. As the Senate takes up the legislation, AAUW will continue to advocate for legislation reflecting our priorities.
- On May 20th, the Employee Benefit Research Institute released a report showing women lag behind men in total

due to the gender wage gap, which results in women's making and receiving smaller retirement contributions on average than men.

- This has been a busy month for the Common Core Standards. The governors of Oklahoma and North Carolina signed legislation repealing the standards in their states. Each state will develop and implement its own standards instead. In other news, AAUW-NYS joined forces with other national groups to organize support for the Common Core by launching a series of teacher-testimonial wideos on the need for the educational standards. AAUW supports the Common Core standards and applauds AAUW-NYS for their coalition work.
- In response to the White House's 60-page task-force report outlining recommendations for the "My Brother's Keeper" initiative aimed at young men of color, more than 200 African-American men signed an open letter asking President Obama to create a similar program for young women of color.
- A Public Religion Research Institute survey revealed that a majority of Americans support the contraceptive coverage mandate within the Affordable Care Act. Sixty-one percent said they believe publicly held corporations should be required to provide contraceptive coverage to their employees. These results come as the public awaits a decision from the Supreme Court in the Sebelius v. Hobby Lobby case. AAUW has signed on to an amicus brief in this case supporting employee's access to contraceptive coverage.
- This week, advocates charged that Congress' continued delay in passing AAUW-supported legislation to strengthen the Voting Rights Act, which was weakened by a 2013 Supreme Court decision, leaves many voters vulnerable to infringements of their voting rights. On a related note, a study released this week found evidence of underlying discriminatory intent behind many voter ID laws.
