INTERBRANCH COUNCIL UPDATES:

November 18th IBC Meeting

The quarterly meeting of the Interbranch Council met at the Thornhill Branch Library in Creve Coeur. In attendance from the St. Louis Branch were Jan Scott, IBC Chair; Carol Davis McDonald, IBC treasurer; and Fran Irwin.

KWG Member Kay Meyer gave an update on Jean Shull, past AAUW MO president and chair of the IBC Downtown Lunch Group. Following Jean's car accident, she suffered a fall in her home. She was diagnosed with a broken lumbar vertebra, which was subsequently injected with a glue compound for healing. While in rehab at Bethesda-Dilworth, she began having back pain and found it difficult to stand. She currently is at The Glen at Aberdeen Heights, 505 Couch Avenue, Kirkwood. Kay will be handling the Downtown Lunch reservations for the time being.

Shirley Breeze, Ferguson-Florissant Branch copresident, chair of the Missouri Women's Network, past president of AAUW MO and AAUW regional director, provided an update on the national calendar, election dates, and other national items of interest. She also announced the date of the Women's Issues Legislative Retreat, which will be held in Columbia, MO, on January 10, 2015, 9 AM to 2:30 PM, at the Hy-Vee Grocery conference room (see attached flyer).

Deb McWard, Creve Coeur Branch president, reviewed proposed updates to the IBC NCCWSL (National Conference of College Women Student Leaders) scholarship guidelines. It was agreed that IBC would concentrate on funding one scholarship plus air fare. If funds allow, additional scholarship applicants would be considered. Students must attend an AAUW partner college or university and must have at least one more semester of classes to be eligible for the IBC scholarship. Branches are encouraged to provide at least \$50 to the IBC NCCWSL Fund, and individuals donations are very welcome.

AAUW Metro St. Louis Interbranch Council (IBC) will sponsor a woman college student to attend AAUW's National Conference for College Women Student Leaders in the spring. Students who have attended in the past tell us that the experience has been life-changing for them. Money for this sponsorship is designated in the IBC budget, and branches contribute as well. International Relations Lecture Series

Jan 13: <u>The End of the Ottoman Empire, the Creation of</u> <u>the Modern Middle East</u>

Speaker: Dr Tahmineh Entessa, Retired Assistant Director of the Graduate Program in International Relations, Webster University. What role did the politics of oil and the politics of containment of communism play in the creation and maintenance of the modern Middle East? How did the fall of the Soviet Union change the focus of the Western influence in the Middle East? How did these political events create the conditions for the development of terrorist groups? Dr Entessar will answer these questions and enlighten us on how these issues affect us and the world.

Feb 10: The Status of Women in the World

Speaker: Dr. Farida Jalalzai, Assoc. Professor and Chair of Political Science at the Univ. of Missouri-St. Louis. This talk will focus on trends in women's office holding worldwide. Dr. Jalalzai will analyze the factors related to women's ascension to legislative and executive office holding and potential effects of women's inclusion on policy outcomes and institutional practices. Mar 10: <u>Will 3-D Printing Change the World</u>? Speaker: Warren Doherty, Market Wide

Format Specialist at Konica Minolta.

The present possibilities of 3-D printing are both alarming and inspiring, from the printing of working guns by individuals in homes to creating complex prosthetic body parts. How will such manufacturing be regulated? How will it affect economics, politics, war? Mr. Doherty, from a background of 23 years in the printing and copying field, will explain how this revolutionary technology works, what it has produced in the past, what it is doing in the present, and how it could affect our world in the future. Apr 14: Shattered Arctic Ocean in Peril

Speaker: Randall Hyman, Fulbright Scholar in Journalism. Randall Hyman has covered the Arctic environment since 1980 for a range of publications, from Smithsonian magazine to National Geographic books. In 2013 he traveled four months across the High Arctic as a Fulbright Scholar and guest of the Norwegian Polar Institute and then returned in August 2014 as a guest of the National Science Foundation. With each trip to the High North, he has found another reason to return, drawn by the region's austere beauty and perilous future. The Arctic Ocean, in particular, serves as a crystal ball for the rest of the planet, a reservoir of change, vast yet fragile, and severely impacted by global human activity. In his presentation, Mr. Hyman examines warming waters, melting sea ice, and the secret lives of deep-water clams as harbingers of the future we are forging for our entire planet. National Report from Shirley Breeze:

- The elections are over; there is a bit of good news from the general dismay. For the first time in history, there are 100 women on Congress 80 in the House and 20 in the Senate. It is a long way from parity, but it is a start. Remember, our motto is "50/50 by 2020."
- Make plans to attend the national convention in San Diego next June 18-21. The AAUW web site has a brief first take on the amazing planned workshop topics.
- In February and March 2015, materials will be available on the AAUW web site and in *Outlook* containing the bios of the candidates running for national offices. A paper ballot can be requested on April 1st, and on April 15th on-line voting opens. Help determine the direction of this exceptional organization by casting your ballot.
- Several helpful leadership aids are on the web site. Quick Facts sheets deal with current policy issues such as Common Core, STEM, Pay Gap, Health Care, Title IX, etc.
- Look for the new research report, *Moving the Needle: Women in Engineering and Computing*, to be published early next year.
- There are two brand new items on pay equity. One is from the Bureau of Labor Statistics entitled *Median Weekly Earnings, 2004-2014;* it compares men's and women's salaries. The other one is from the Institute for Women's Policy Research (9-2014); it is *The Gender Wage Gap 2013: Differences by Race and Ethnicity.*
- AAUW is searching for a staff person to deal with state public policy issues. If you know of someone who would be a good candidate, tell them to visit the web site for information.

Washington Update

AAUW Members Lead Fight for ERA Ratification in State House. The <u>Illinois state legislature</u>'s fall veto session began last week, and AAUW of Illinois members wasted no time in resuming their advocacy for the House to ratify the Equal Rights Amendment (ERA). AAUW of Illinois and allied organizations successfully urged the Senate to ratify the ERA in May. If the House does not ratify the amendment before the end of 2014, then advocates will need to start again in both houses during the next legislative session. Special recognition goes to AAUW-IL public policy chairs Jo-An Takamoto Sabonjian and Olga Weidner and AAUW-IL legislative consultant Paula Purdue, who have been working around the clock to move more votes into the "yes" column.

Department of Education Investigates K-12 School Districts for Title IX Violations. In addition to the greatly publicized list of 87 colleges and universities under investigation for Title IX violations, the U.S. Department of Education's Office of Civil Rights is also investigating 24 elementary and secondary schools for potential mishandling sexual assault cases. Under Title IX, any K-12 public and private school that receives federal funding is required to respond effectively to sexual harassment or assault incidents. This announcement of elementary and secondary school investigations is part of the federal government's recent increased commitment to preventing and responding to sexual violence.

AAUW Cheer: In a victory for rape survivors and their advocates, Manhattan District Attorney Cyrus R. Vance Jr. announced on Wednesday that his office has pledged as much as \$35 million to fund rape kit testing across the nation. This funding will allow evidence in up to 70,000 rape cases to receive DNA testing, which could identify or eliminate suspects.

AAUW Jeer: Last week, 28 Columbia University students protested the university's rape and sexual assault policy by carrying mattresses around campus— this week, the university responded by charging them \$471 in cleaning fees. The protest was inspired by Columbia senior Emma Sulkowicz's decision to carry her mattress around campus to draw attention to the school's dismissal of her case against her alleged rapist. In last week's protest, the students left their mattresses on the street outside the university president's lawn, resulting in the clean-up fees. On a brighter note, Ultraviolet, one of AAUW's allies in the fight against campus sexual violence and other issues, announced it will pay the \$471.

AAUW Cheer: TIME has apologized for including "feminist" in its annual poll of which words should be banned in the coming year. The magazine expressed regret that the word's "inclusion [on the list] has become a distraction from the important debate over equality and justice."

AAUW Jeer: Police in Indonesia have been conducting scientifically unfounded and demeaning

physical tests to determine if female police recruits are virgins, according to a Human Rights Watch report issued in November.

AAUW Jeer: In late October Walmart's online store had a subsection of Halloween costumes for plus-size women labeled "fat girl costumes." After a flurry of attacks on Twitter and outreach from the Huffington Post, Walmart deleted the "fat girl" category and relabeled the page "Women's Plus Size Costumes."

AAUW Cheer: Three Ohio congresswomen—Reps. Mary Kaptur (OH-09), Marcia Fudge (OH-11), and Joyce Beatty (OH-03)—sent a letter to all Ohio higher education presidents advocating for a stronger commitment to improving and enforcing policies regarding sexual violence on college campuses. <u>The</u> <u>letter listed AAUW as a suggested advocacy group for</u> <u>colleges to reach out to in their development of a plan</u> to prevent and respond to incidents of sexual assault.

AAUW Jeer: Goes to not one, not two, but THREE individuals whose statements were so out of touch with the real challenges facing working women that we couldn't choose only one to feature here: Former Florida Gov. Jeb Bush, New Jersey Gov. Chris Christie, and Fox News commentator Kimberly Guilfoyle. Bush didn't know what the Paycheck Fairness Act was; Christie said he is "tired of talking about raising minimum wage" (what about the women who make up nearly two-thirds of minimum wage workers?); and Guilfoyle claimed young women don't "get" voting because they don't have to worry about paying bills, education, crime, or health care.

Bits and Pieces

• AAUW Vice President of Government Relations Lisa M. Maatz spoke on a panel at the White House, marking the fifth anniversary of the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act. Maatz's main role on the panel was to discuss the importance of addressing gender-based hate crimes in prevention and enforcement efforts. • A Federal Reserve Bank of St. Louis study analyzed the work of more than 10,000 academic economists and found that mothers produced more research over the course of their career than women without children. Although the findings address a very narrow sliver of the workforce, it's worth noting that moms overall typically face a wider gender pay gap than women without children and the gender pay gap persists at higher levels of education.

AAUW Vice President of Government Relations Lisa
M. Maatz appeared on Voice of America on October

27th to speak about how women voters will affect the upcoming election. The segment was broadcast live in Afghanistan during their primetime hour. Watch the video on YouTube to hear Lisa's answers in English and hear the anchor and translator speaking in Dari!
