#### Past AAUW of Missouri President Mary Jean Shull

Jean Shull died on December 13, 2014. Jean was a member of the Kirkwood-Webster Groves Branch for over 35 years. She was branch president (1983-1985)

and currently was serving on K-WG's board as bylaws chairperson and college-university representative. Jean also was St. Louis IBC chair and kept the Downtown Lunch Group going for many years. She served as chair of the St. Louis Equity Roundtable in 1991; this community project gave birth to the St. Louis Area Educational Equity Coalition, which was used to educate local school districts, community organizations, and clubs about AAUW's gender equity program, Shortchanging Girls. She also had been active in the Girl Scouts and with her church, Kirkwood United Methodist. Jean will be missed.

The AAUW Metro St. Louis Interbranch Council Barbara Lackritz Service Award committee met recently to review applications submitted by area branches nominating a current branch member who has met the requirements as set forth in the IBC Guidelines. Mar 10: <u>Will 3-D Printing Change the World</u>? Speaker: Warren Doherty, Market Wide Format Specialist at Konica Minolta.

The present possibilities of 3-D printing are both alarming and inspiring, from the printing of working guns by individuals in homes to creating complex prosthetic body parts. How will such manufacturing be regulated? How will it affect economics, politics, war? Mr. Doherty, from a background of 23 years in the printing and copying field, will explain how this revolutionary technology works, what it has produced in the past, what it is doing in the present, and how it could affect our world in the future. #### Apr 14: Shattered Arctic Ocean in Peril

Speaker: Randall Hyman, Fulbright Scholar in Journalism. Randall Hyman has covered the Arctic environment since 1980 for a range of publications, from Smithsonian magazine to National Geographic books. In 2013 he traveled four months across the High Arctic as a Fulbright Scholar and guest of the Norwegian Polar Institute and then returned in August 2014 as a guest of the National Science Foundation. With each trip to the High North, he has found another reason to return, drawn by the region's austere beauty and perilous future. The Arctic Ocean, in particular, serves as a crystal ball for the rest of the planet, a reservoir of change, vast yet fragile, and severely impacted by global human activity. In his presentation, Mr. Hyman examines warming waters, melting sea ice, and the secret lives of deep-water clams as harbingers of the future we are forging for our entire planet. # Missouri Women's Network

#### **Report: Missouri Legislative Retreat 2015** Shirley Breeze - January 10, 2015 – Columbia, MO

Women representing the major women's organizations in the state met in Columbia on January 10 to establish legislative priorities for the 2015 Missouri legislative session. This annual event brings together women's groups representing thousands of women; included in this working session were members from AAUW, NOW, League of Women Voters, Missouri Women's Leadership Coalition, Missouri Women's Political Caucus, Business Women of Missouri, and others. There were some university students in attendance also.

The day began with an analysis of the November 2014 elections as they impacted women. There are now 49 women in the Missouri legislature. In the House there are 24 Republican women and 19 Democratic women, the first time the Republican women outnumbered the Democratic ones (26.3%); the national average of women in State Houses is 25.5%. There are six women in the Senate, five Democrats and one Republican (17.6%); the national average of women in State Senates is 20.8%. There are no women

statewide office holders. The national average for women in statewide offices is 22.6%.

Rev. Rebecca Turner, executive director of Faith Aloud, was the keynote speaker at the morning session. She addressed the issues surrounding the unrest in Ferguson, what is being done to remedy the inequities, and the history behind how the situation became so volatile.

In establishing priorities for 2015, the highest priority was identified as the Equal Rights Amendment/Pay Equity and Reproductive Rights. In the second tier of priorities were Social Justice (Racism), Ethics, and Poverty; the third tier consisted of Labor/Minimum Wage/Right to Work/Discrimination, Violence Against Women, and Education. Gun Regulation and Voting Rights were also addressed.

These topics were chosen after a review of the prefiled bills for the 2015 session and the public statements of legislators as to what they would be sponsoring and working on this session.

These priorities will be used in lobbying efforts with the state legislature. As proposed legislation is debated and voted upon, the women's lobbyists will use the priorities as a guide as where most women in the state want efforts placed. Efforts are also directed at topics where there is no other group working on them.

#### Washington Update

New Research Suggests that Electing More Women May Be the Key to Ending Partisan Stalemate. Political scientists at the University of North Carolina and the University of Kansas released a new study this week suggesting that partisan gridlock in Washington, D.C., may be due to the tendencies of male members of Congress to resist bipartisanship. Male respondents to a nationwide survey were less likely to engage in crossparty discussion and more likely to say they would support political opinions without considering others' reasoning. The survey asked these questions of voters, though, not elected officials. Still, the researchers said their findings suggest that more women in Congress might lead to more bipartisan communication and compromise and less political fighting and gridlock.

House Committee Drops Voucher Proposal in What Remains a Bad Education Bill. During the House Committee on Education and the Workforce's consideration of the Elementary and Secondary Education Act/No Child Left Behind Act earlier last week, Rep. Messer was forced to withdraw his amendment, which would have allowed Title I dollars to be used at private schools (essentially a voucher proposal). This victory is a credit to you, the entire AAUW activist network, and education advocates everywhere who raised their voices in opposition to vouchers. Unfortunately, private school the "portability" provision which would allow Title I money for low-income students to follow them to the public school of their choice did pass. AAUW opposes "portability" because it will result in fewer resources for schools which need them the most and is a stepping stone to private school voucher efforts (such as Rep. Messer's amendment). A House vote is expected on the bill later this month.

AAUW's how-to guide has everything you need to know about scheduling, preparing for, and making the most of your in-district meeting with your members of Congress (during the meeting and during follow-up). (http://www.aauw.org/resource/how-to-hold-ameeting-with-your-elected-officials/) Here are two more "top tips":

- Be persistent in requesting a meeting. Don't be afraid to follow up your e-mail with a phone call – and your first phone call with another phone call! You can

also ask other members of your branch to request a meeting and work with coalition partners in your community to identify the best messenger to make the request.

- Be strategic and specific with your ask. For example, "We would like a half-hour conversation with Rep. to talk about equal pay, an issue that's on everyone's minds! We have a concerned group of his/her constituents who request that Rep. meet with us," instead of a more general ask like, "We would meet with like to the representative." Finally, writing letters to the editor is another way to bring the issues to our representatives' attention. So good luck with your meetings - and let us know how it You can request AAUW materials and staff goes! support in advance (for free!) and share your results in an easy, online form so we can recognize your efforts.

**AAUW Cheer:** Rhode Island Gov. Gina Raimondo (D), the state's first woman governor, launched the Rhode Island Pay Equity Tip Line, a hotline allowing workers to report employers who violate the Rhode Island law that bans gender-based wage discrimination.

**AUW Jeer:** Yet another study demonstrates an unfortunate point that we have long known to be true: Gender biases are alive and well in the professional sphere. A Northeastern University professor analyzed student reviews on ratemyprofessors.com and charted the words used to describe professors, such as "genius," "annoying," and "funny." The interactive chart is broken down by gender and academic department and shows that women professors were more likely to be judged on their appearance and personality and more likely to be criticized than their male peers.

**AUW Cheer:** Rutgers-Camden University School of Law Vice Dean Adam Scales spoke out against sexism in academia after learning that a female law professor had received sexist remarks about her personal appearance in a student evaluation. In an e-mail to the university's entire student body, Scales discussed the harmful implications of gender bias and urged students to use professor evaluations as the "important tool" that they are, not as a tool for gendered comments about professors' appearances.

**AAUW Jeer:** Of all the ads that ran on Super Bowl Sunday, the one that elicited the greatest backlash was an Always commercial about empowering girls – really. Much like AAUW's Title IX PSA, the "Like a Girl" commercial encourages all of us to change the conversation so that "like a girl" means to be strong, fast, and powerful, instead of the typical gender stereotype of weakness. But some people took to Twitter to complain that the ad was reverse-sexist (whatever that means!) for focusing only on girls. This backlash just proves how much more progress we need to make in breaking down gender stereotypes – a task that 11 campus teams across the country are undertaking as part of the AAUW Campus Action Project (CAP) grants, sponsored by Pantene.

AAUW Cheer: Following persistent advocacy from AAUW of North Dakota members, the North Dakota House passed a bill yesterday that would ban employers from firing, threatening, or otherwise retaliating against an employee who discusses his/her compensation with another person. This legislation can help close the gender wage gap by allowing employees to speak freely about their earnings and uncover wage discrepancies. AAUW was involved from the start, working with the North Dakota Women's Network to drive messages to the House committee members urging a "do pass recommendation" for the bill and then focusing efforts on the full House before yesterday's vote. AAUW Vice President of Research Dr. Catherine Hill and Vice President of Government Relations Lisa M. Maatz also briefed the House committee about the causes behind the gender pay gap and the legislative solutions we need to address this very real problem.

**AAUW Jeer:** During a conference call last month, Rep. Louie Gohmert (R-TX) commented that some GOP congresswomen — whom he called "our Republican females" — sent the "entirely wrong message" by calling for a rape exception that didn't depend on whether survivors had reported the assault to law enforcement in the 20-week abortion ban bill. Wow. Speaking of entirely wrong messages, they're called "members of Congress," not "our females." And AAUW is glad to see them speaking a little truth to power.

#### **Bits and Pieces**

• After a South Dakota news outlet discovered a gap of more than \$41,000 annually between the male and female head coaches' salaries at the University of South Dakota, they turned to none other than **AAUW's Vice President of Government Relations Lisa M. Maatz** for a response. Maatz spoke about the persistence of gender pay discrimination and AAUW's analysis of coaches' salaries for the 2014 March Madness basketball tournament.

• On Tuesday, Sens. Tim Kaine (D-VA) and Claire McCaskill (D-MO) introduced the Teach Safe Relationships Act of 2015, which would include information on preventing sexual assault, domestic violence, and dating violence in public health education classes. AAUW supports this legislation and other

policies that aim to curb sexual harassment and violence in schools.

• The Second Circuit Court of Appeals heard arguments last week challenging the legality of unpaid internships. Unpaid internships have become commonplace throughout the country as students look for opportunities to strengthen their resumes and gain valuable experience outside the classroom, though not all employers follow the rules. AAUW is proud to pay our interns!

• The Department of Labor recently proposed updates to sex discrimination guidelines for federal contractors and subcontractors, which were originally issued in 1970. The updates will address sexual harassment and discrimination based on gender identity and pregnancy.

• Last month the House passed 12 bills to help combat human trafficking. Most of those proposals were passed by a voice vote. AAUW supports the approach of several of the bills and will continue to monitor their progress as they move through the Senate.
