New York, Pacific/San Francisco, Philadelphia, and Boston branches are formed in 1886.

Human Trafficking – A Challenge to Action Malaika Horne, PhD

"Knowledge builds confidence and empowers," so the saying goes. This is why we're delighted to announce our foray into a new program at the University of Missouri-St. Louis called **Lifelong Learning** @ **UMSL**. The aim is to create learning communities for older adults (50 and older) who seek to be more active and engaged.

The first will be a symposium **November 8, 2013,** 8:00 AM to 12:30 PM at the UMSL JC Penney Conference Center. A light breakfast will be served. The topic is: **Human Trafficking – A Challenge to Action**. Dr. Ruth lyob, UMSL professor and noted author in the field, will deliver the keynote address along with three panelists who are practitioners. Two have been confirmed: Rebecca Feldmann, attorney, Legal Services of Eastern Missouri, and Amanda Colegrove, director, Rescue and Restore, a coalition of groups under the auspices of Catholic Charities. These agencies assist victims in addition to fighting various aspects of this horrendous crime.

Lifelong Learning @ UMSL is designed to enrich the group by empowering individuals as they grow and learn together. By attending these sessions, participants will deepen and broaden understandings and have extraordinary discussions, inspiring reflections and actions. We're also happy to announce a budding partnership with AAUW, as addressing human trafficking is a big concern for this important organization. With the addition of highly educated and active older adults such as members of AAUW, we're confident that we'll have a successful symposium. The registration fee is \$20 per participant. Early registration is September 16 to October 25.

Women's Financial Series beginning in October

If you'd like to gain confidence in your ability to make financial decisions and learn how to manage your money more effectively, then a class this fall cosponsored by University of Missouri Extension and the Older Women's League (OWL) can help.

The Women's Financial Education Series is designed to help individuals, especially women, increase their current level of financial knowledge, develop confidence in their decision-making ability, and gain control of their lives through informed money management.

This five-session series will be held 6-8:30 p.m. Tuesdays, October, 1, 8, 15, 22 and 29 at the University of Missouri Extension Center, 10650 Gateway Blvd. in Creve Coeur. Instructors include University of Missouri faculty and local experts. The fee is \$49, which covers five sessions, a financial workbook, and other financial management resources. Session topics include financial management, credit, insurance, planning for investing, retirement, and estate planning. Registration is required. The deadline is September 24. Important Federal Legislation – 2013

To express your opinion to your legislator, go to the national web site, www.aauw.org, and click on "Take Action" on the right side, midway down. There you will be able to find your members of Congress and topics to select. Messages are already written as suggestions, but you can always add to it or write your own thoughts.

National Women's History Museum (HR863) (S398):

- No cost to government; privately funded
- Would create a federal commission to determine possibility of building a National Women's History Museum in DC
- Reps Carolyn Maloney (D-NY) and Marsha Blackburn (R-TN) are lead sponsors
- Senators Susan Collins (R-ME) and Barbara Mikulski (D-MD) are lead sponsors

Paycheck Fairness Act (S84/HR377):

- Expand the Equal Pay Act
- Allow individuals to sue for fair wages
- Clarify acceptable reasons for differences in pay and close loopholes (employers would have to prove wage gaps between men and women are caused by something other than sex)
- Rep. Rosa DeLauro (D-CT) and Senator Barbara Mikulski are lead sponsors

<u>Convention on the Elimination of all Forms of</u> Discrimination Against Women:

- New push to ratify international treaty
- 187 countries have ratified; those who have not are US, Sudan, South Sudan, Iran, Somalia, Palau, and Tonga
- Secretary of State John Kerry strongly supports ratification

ERA (SJR15/HJR43):

- Eliminates the deadline for passage of the ERA
- Both House and Senate bills were filed
- Lead sponsors in Senate: Benjamin Cardin (D-MD), Mark Kirk (R-IL), Tom Harkin (D-IA)
- Senators Barbara Mikulski (D-MD) and Lisa Murkowski (R-AK) have signed on as cosponsors
- House Sponsors include: Tsongas, Speir, Ellison, Wasserman, Moore, and Clay

<u>Government Pension Offset/Windfall Elimination</u> Provision (HR1795) (S896):

- Social Security Fairness Act
- Repeals Government Pension Offset and Windfall Elimination Provisions

 HR1795 – Reps Rodney Davis (R-IL) and Adam Schiff (D-CA) are lead sponsors. Senate sponsors are Begich (D-AL) and Collins (R-ME)
