Human Trafficking – A Challenge to Action November 8, 2013 – 8:00 a.m. – 12:30 p.m. Malaika Horne

Come broaden and deepen your understanding of provocative and sensitive issues by attending *Lifelong Learning @ UMSL* at the University of Missouri-St. Louis, North Campus, 8001 Natural Bridge, Normandy, MO. The aim is to create learning communities for older adults (50 and older) who have a love of learning and seek to be more active and engaged.

The first will be a symposium November 8, 8:00 AM to 12:30 PM, at the UM-SL JC Penney Conference Center. A light breakfast will be served.

The topic is: Human Trafficking – A Challenge to Action. Dr. Ruth Lyob, UMSL professor and noted author in the field, will deliver the keynote address along with three panelists who are practitioners: <u>Rebecca Feldmann</u>, attorney, Legal Services of Eastern Missouri, and <u>Amanda Colegrove</u>, director, Rescue and Restore, a coalition under the auspices of Catholic Charities. These two aforementioned agencies assist victims in addition to fighting various aspects of this horrendous crime. The third panelist is <u>Kimberly Ritter</u>, senior account manager for Nix Conference and Meeting Management and leading the company's initiatives in combatting trafficking in hotels.

Lifelong Learning @ UMSL is designed to enrich the group by empowering individuals as they grow and learn together. By attending these sessions, participants will be engaged in extraordinary discussions, inspiring reflections, and actions. While we target older adults (over 50), we seek to

have intergenerational involvement, so all ages are welcomed. Therefore, we forge connections across age groups, cultivating relationships, bridging social capital and promoting civic engagement.

The Gender Pay Gap: Missouri

According to the most recent statistics from the US Census Bureau, the median earnings for US women working full time, year round, were just 77% of the US men's median earnings – a gap of 23%. Progress to close the gap has stalled during the last decade, and the gap is even larger for women of color. This pay gap begins early in women's careers. According to AAUW's research report, *Graduating to a Pay Gap*, women only one year out of college, working full time, were paid on average just 82% of what their male counterparts were paid. After controlling for hours worked, occupation, college major, employment sector, and other factors associated with pay, the gap shrinks but does not disappear. About one-third of the gap cannot be explained by these factors commonly understood to affect earnings.

Fifty years after passage of the Equal Pay Act, it's clear the pay gap is unlikely to go away on its own. That's why the AAUW and its more than 165,000 members and supporters are leading a nationwide campaign to close the pay gap and end pay discrimination. Federal Circuit Rules in Favor of Veterans Seeking Disability Benefits after Sexual Assaults. In an encouraging step for survivors of military sexual assault, a federal appeals court recently ruled that a veteran's failure to report a sexual assault is not evidence that the assault did not occur. In *AZ v. Shinseki* and *VA v. Shinseki*, two veterans sought disability benefits for post-traumatic stress disorder that they said stemmed from sexual assaults they suffered while on active duty. Because the veterans did not file complaints at the time the alleged assaults occurred, their service records did not contain any mention of the assaults. Relying on the veterans' failure to report as evidence that the assaults never occurred, the U.S. Department of Veterans Affairs and the Court of Appeals for Veterans Claims denied disability benefits.

On appeal, the U.S. Court of Appeals for the Federal Circuit held that the "VA may not treat a claimant's failure to report an alleged sexual assault to military authorities as pertinent evidence that the sexual assault did not occur." The court recognized that "many service members fear that the act of reporting a rape to military authorities will subject them to personal and professional reprisals." While other courts are not required to follow it, the ruling is promising. The Federal Circuit's ruling recognizes the real barriers to justice faced by survivors of military sexual assault. AAUW is working to break down those barriers by supporting the lawsuits of survivors and supporting legislation to improve the military's handling of sexual assaults.

Washington Update

This week, the White House invited AAUW to attend an event with President Obama and Vice President Biden and asked AAUW to have a representative on the stage with the President and Vice President. Why? Because OUR actions demanding immigration reform have been noticed in Washington, D.C.

Since AAUW members voted in June to add to our public policy priorities support for "the civil and human rights of all immigrants, including a fair and just path to legal status," AAUW activists have sent messages to representatives from almost every congressional district, demanding immigration reform now. In addition, the AAUW Action Fund Lobby Corps has delivered this message to over 200 Senate and House offices.

An AAUW intern who is a Deferred Action for Childhood Arrivals ("DACA") student was chosen for the honor of representing all of us. After graduating with honors from high school in June, she is now in her first year in the honors college at Montgomery College in Takoma Park, MD. She's taking general education courses now and hopes to one day to become a marine biologist.

House Passes Bipartisan Bill Protecting Students from Predators

Last week the House passed the Protecting Students from Sexual and Violent Predators Act (H.R. 2083). The act requires public schools to conduct comprehensive background checks for employees or applicants with unsupervised access to children and prohibits school districts from hiring anyone convicted of violent crimes such as rape, sexual assault, or child pornography. Currently, legislation on background checks and hiring practices is inconsistent across states; H.R. 2083 seeks to make the process more uniform nationwide.

AAUW supports policies that create safe learning environments. In addition to policies protecting students from teachers who have violent criminal backgrounds, we also need policies to protect students from peer-to-peer bullying and sexual harassment, as detailed in AAUW's report, Crossing the Line (2011).

Bits and Pieces

Last week the Obama Administration clarified that people who sign up for health insurance through the exchanges by March 31, 2014, will not have to pay the penalty even though their health insurance will not have gone into effect by that date.

The Internal Revenue Service (IRS) announced that • the start of the 2014 tax filing season will be delayed by one to two weeks due to the federal government shutdown. The April 15 filing deadline will remain because that date is fixed by statute.

A new survey released last week reaffirms the "STEM shortage," meaning that businesses are struggling to find qualified employees to fill job openings in science, technology, engineering, and math (STEM).

AAUW supports efforts to supplement our own • home-grown STEM workforce through a STEM education initiative implemented as part of immigration reform legislation. The initiative would be funded through fees collected from U.S. employers who recruit foreign STEM workers and used to educate the next generation of American STEM workers. Write your representative today and ask him or her to include this fund in any immigration proposal!

The NAACP has appointed Lorraine C. Miller as • interim president and CEO. Miller will begin serving in this role on November 1; current NAACP President and CEO Benjamin Jealous has announced he will step down at the end of the year. Miller will be the first woman to serve in the president-executive secretary's role since 1916.

On Monday, New Jersey became the 14th state in the country to recognize same-sex marriage. As the marriages began, Governor Chris Christie (R) announced that he was dropping his challenge to the law.

Last Monday seven current and former UConn students filed a Title IX complaint against the university alleging school administrators were indifferent to their campus sexual assault claims. High-profile antidiscrimination attorney Gloria Allred is representing the students.
