**Bylaws Amendments:** 

At the December Brunch, hoping to have a quorum of at least 30% of our members, we will vote to amend Article XIII of the branch bylaws, as follows:



#### ARTICLE XIII. MEETINGS OF THE MEMBERSHIP

**Section 1. Annual Meeting**. The Organization shall hold an annual meeting to conduct the business of the Organization, including but not limed to, electing officers, establishing dues, amending bylaws, and receiving reports. This meeting shall be held in April or in May.

Section 2. Membership Meetings. There shall be at least at total of two (delete: four general) meetings each year. The Organization board shall determine the time and place for these meetings.

Section 3. Recording of Minutes. At each meeting, a secretary shall be appointed by the president to record and keep minutes.

Section 4. Quorum. The quorum shall be **20 percent (delete: thirty percent)** of the Organization members.

Former Saint Louis University Dean of Student Affairs **Mary Bruemmer** was named a "dame commander" of the Order of St. Sylvester, Pope and Martyr.

Bruemmer, 96, received the honor Wednesday during a party celebrating her 26 years as a volunteer, service she gave after retiring from university employment. St. Louis Archbishop **Robert Carlson** presented



Bruemmer with the cross medallion from the order, founded in 1841 to recognize lay people for apostolic works.

"Mary has been a role model, a guiding light and a moral compass for generations of SLU students and alumni," Carlson said. "She has also served God in so many ways, and this honor from Pope Francis tells the world how she has served Him and her Church." University President **Fred P. Pestello** also was on hand to toast Bruemmer's retirement.

AMY WEISSER is writing to us from South Korea where she is visiting her son. She is hoping to join us for the brunch meeting on December 11th. Her "travelogue" is quite interesting:

"I am very much enjoying my stay here. It's a rainymisty day here, which will

delay my daily walk till later. It's so strange being in a place where you can't even recognize the alphabet; but many signs are in English besides Korean, and the country has incorporated the American way of doing things in many areas.

"On Saturday we went to Seoul and toured an ancient palace and a beautiful Buddhist temple that was truly amazing. We also got caught up in a huge demonstration (totally peaceful) regarding the ouster of the current president, who is a woman. As an American, I felt proud to watch the thousands of demonstrators file past, peacefully holding candles, chanting anti-president slogans and waving Korean flags. This has got to be one of the best things the US has exported to this country. There was no shortage of children, even babies in strollers, joining their parents. I took a couple of short videos. I have never seen so many police in one place in my life, however. There were thousands of them present, in full riot gear. I believe they were deployed to keep the demonstration away from the Blue House, which is Korea's White House, as well as to keep order, which I believe they did quite well. Little did we know that the Blue House was not terribly far away from our sightseeing. But all turned out well, and we ducked into (continued on next page)

a convenient Starbucks (of which there are many here) to sip a java chip frappe and devour a lemon scone.

"I will close with my good wishes to you both and the other branch members, and look forward to seeing all at Sue's brunch."

The next day, Amy sent a follow-up message: "My son told me that on election day he was looking at the election news on his laptop at school. One of the brighter little girls came up to his desk and said: "Teacher, no Trump. Trump bad. Say no Trump." He was really surprised that such a young student---3rd grade--would even know of Trump.

"I'm sure they are quite concerned about his election here and what it will mean for future Korean-American relations. I'm certainly no political expert, but anyone can see how progressive this small country is and how it's modeled on the US in so many ways---economic, political, and social as well. But I read that S. Korea is the size of Indiana, and they've got the North Koreans right on their border, as well as the Chinese breathing down their necks. We need to support this country as much as we can. I'm fully in favor of keeping a sizeable force of US troops here as long as the Koreans are fine with it. Ditto Japan.

"Well, that's it for Amy's letter from South Korea, Monday edition. It's after 2, and I'm ready to reheat the left-overs of Chinese take-out we had last night."

*Roe v. Wade*'s 44<sup>th</sup> anniversary is January 2017. Planned Parenthood turned 100 in October 2016. Yet the state of reproductive healthcare, particularly for women, is still in question both nationally and internationally.

Dr. Ellen Carnaghan, professor and chair of Political Science and department chair at St. Louis University, teaches and conducts re-

search in Russian politics, the politics of post-communism and political change in many aspects, including democratization and social movements. Her recent book, *Out of Order: Russian Political Values in an Imperfect World*, examines how the political values of Russian citizens have been shaped by the disorderly conditions that followed the collapse of communism. She is currently working on a new book, *Constructing Citizens: Mass Protest in Autocratic Regimes*, which explores methods of overcoming obstacles to democratization in post-communist regimes that has involved field research in Georgia, Ukraine, and Russia.

## Immigrants and Refugees from a Global Perspective

Uma A. Segal is professor and baccalaureate program director in the School of So-

cial Work at the University of Missouri, St. Louis. Dr. Segal served 2007-2015 as resident scholar on migration on the Advisory Board of the Katherine A. Kendall Institute (KAKI), an international arm of the Council on Social Work Education (CSWE). She was editor in chief of the *Journal of Immigrant & Refugee Studies* from 2004-2012, and is co-editor of the book *Immigration Worldwide: Policies, Practices, and Trends*. Dr. Segal has participated in research projects on cross-national comparisons of migration in Athens, Greece, Sofia, Bulgaria, and Tokyo, Japan, and has been an invited speaker in several Asian and European countries. In addition, her research has taken her to Brazil, India, Russia, and the United Kingdom.

# AAUW of MISSOURI UPDATE: October 15th Board Meeting Highlights

- Sue Shineman, membership vice president, reported that there are 783 Missouri members listed on the national Website, 659 paid, 129 unpaid at present and these members will be dropped as of 11-30-16 if they remain unpaid. There are 431 National members living in Missouri, 85 have not paid their dues.
- Julia Triplett, AAUW Fund chair, reported that the Century Club and Century Club Plus deadline for contributions is December 31st. A member can find how much she has contributed to date by going online, using membership name and number.
- Joyce Katz, communications/web manager, would like to encourage people who like Facebook to like the AAUW MO page.
- Karen Francis and Pat Shores, public policy co-chairs, said that there are 27 female legislators who proclaim to be AAUW members. It was agreed that they should be invited to join AAUW MO. AAUW President Patricia Fae Ho sent a complimentary letter to Karen for her public policy letter that was printed in the St. Louis Post-Dispatch. The letter was sent to branch presidents suggesting they send it to their local newspapers. The proposed 2017-2019 public policy revisions are on the national web site, and members may go on line to make comments. Pay equity day is April 4th. A sign-up list for a new state lobby corps was circulated.
- Nicky Stanke, program vice president, discussed her draft of the <u>May 6th annual members' meeting in Columbia</u>. An application has been submitted for an LAF plaintiff to attend.
- Discussion of the strategic plan was led by Diane Ludwig, immediate past AAUW MO president, and Jan Scott, current president.
- Jane Biers, historian, said she will be turning materials from branches and the board over to the state archives.
- **Pam Kulp**, branch incentive grant co-chair, reported that there have been no applications received. Deadlines are in November and March. Updated application process information and application were sent to branch presidents.
- Marianne Fues, governance/bylaws, reported that additional mandated bylaws changes were received from the national office. Changes are to be sent directly to national by January 31, 2017. The major change is referring to branches as "affiliates," but there are bylaws sections where the term "branches" is used, and we can still refer to our branch by name. National is also working on six proposed bylaws amendments which will be voted on by membership at the June 2017 convention.
- The nominating committee needs nominations for president-elect, program vice president, and secretary. Names should be sent to Linda Berube.
- The next board meeting will be by conference call on January 28, 2017, at 1:00 p.m.
