Title IX Corner by Lisa Taylor, Director

Hello Everyone,

Hope you had a wonderful Easter weekend with your families. Here is my Title IX commentary from my Title IX Corner.

President Obama set a goal that by 2020 the United States would lead the world in the percentage of college graduates. To help us achieve this goal, there must be support for **every** student in completing high school so they are ready for college or a career, including pregnant and parenting students. They must not be discriminated against as they persist to stay in school.

Title IX protects pregnant and parenting students from discrimination. Many people are not aware that many schools still discriminate against these students. They place the students in separate, subpar academic programs, enact policies to treat them differently from other students with medical conditions, and prevent them from participating in after school programs.

As reported by the CDC (Center for Disease Control), this has harmful effects on students. CDC reports that 50 percent of teen mothers receive high school diplomas by the time they are 22 years old compared with 90 percent of women who did not give birth as teenagers.

A provision in the Affordable Care Act created the Pregnancy Assistance Fund, which provides grants of between \$500,000.00 and \$2 million annually through 2019 to help underwrite programs that connect young families with the support services they will need. The program is designed to help participants focus on high school graduation, good maternal and child health outcomes, and parenting skills.

In 2011 the House of Representatives introduced the Pregnant and Parenting Students Access to Education Act, which enabled the US Department of Education Act to offer state and local grants for programs that promote education and parenting students.

Title IX is a federal civil rights law that prohibits discrimination on the basis of sex - including pregnancy and parental status - in educational programs and activities. Some additional information you should know:

Classes and School Activities:

Schools must allow students to continue participating in classes and extracurricular activities. They should be allowed to choose whether or not to participate in special instructional programs or classes for pregnant students. They cannot be pressured into taking these types of classes. Students should be provided with reasonable adjustments, like a larger desk, elevator access or allowing students to make frequent trips to the restroom, when necessary, etc.

Absences and Medical Leave:

Absences are excused due to pregnancy or childbirth as long as the doctor says it is necessary. Students are allowed to return to the same academic and extracurricular status as before their medical leave began, which will give them an opportunity to make up any work missed while they were absent. This will also ensure that teachers understand the Title IX requirements related to excused absences/medical leave. Students are entitled to homebound instruction/at home tutoring/independent study.

The school must have and distribute a policy against sex discrimination. The policy must make clear that sex discrimination covers discrimination against pregnancy. Adoption and publication of a grievance procedure should be available so a student knows how to file a grievance if the student feels that s/he has been discriminated against. A Title IX coordinator must be available to assist the student.

Additional Information for Parenting Students:

Harassment - the school must protect the student against harassment, including making sexual comments or jokes about the pregnancy.

Ask for help - students should always feel comfortable in reaching out and asking the school for help. S/he should be allowed to meet with the Title IX coordinator-counselor at any time.

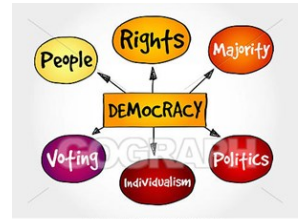

AAUW Legal Advocacy in Action: AAUW Signs On to Two New Amicus Briefs for Supreme Court Cases

Sveen v. Melin

The Supreme Court will address whether revocation-on-divorce statutes violate the contracts clause of the Constitution in *Sveen v. Melin*. AAUW signed on to the amicus brief in this case because women's economic security is one of AAUW's chief concerns.

Here, the amicus brief asserts that revocation-on-divorce statutes frequently revoke beneficiary designations of women and deprive women of more benefits than men, in addition to negatively affecting financially vulnerable divorced women. We joined this brief because revocation-on-divorce statutes, which automatically revoke the prior beneficiary designation of a spouse upon divorce, disproportionately cause damage to women's economic security.

In this case, Mark Sveen purchased a life insurance policy in 1997 and married Kaye Melin later that year. In the following year he named her as the primary beneficiary of his life insurance policy and his two adult children as contingent beneficiaries. Melin and Sveen divorced in 2007, but Sveen never changed the beneficiary designation on his policy.

In 2002 (after Sveen had designated Melin as the primary beneficiary), Minnesota amended its probate code to essentially automatically revoke life insurance beneficiary designations of a former spouse after divorce.

When Sveen died in 2011, Melin was still the primary beneficiary on the policy. The insurance company took procedural steps to determine whether the revocation-upon-divorce statute revoked this beneficiary designation.

Sveen's children and Melin both filed a claim for the proceeds. The U.S. District Court for the District of Minnesota found in favor of the Sveen children, but the U.S. Court of Appeals for the Eighth Circuit reversed the lower court's decision and concluded that the revocation-on-divorce statute was unconstitutional when applied retroactively.

This case was argued before the U.S. Supreme Court on March 19.

National Institute of Family and Life Advocates (NIFLA) v. Becerra

We signed on to an amicus brief that demonstrates the deception and harm produced by crisis pregnancy centers (which attempt to refuse to disseminate accurate information about reproductive options) by highlighting stories of women who tried to seek medical services through these facilities. Denying women the full range of family planning and pregnancy-related medical services, such as abortion, undercuts women's right to choose and has far-reaching consequences that could jeopardize their economic security and access to education. (continued)

In this case, NIFLA challenged a California law that requires licensed pregnancy centers to post or hand out information about the availability of low-cost or free family planning services, prenatal care, and abortion services as well as a phone number to contact to determine eligibility. This law also requires unlicensed facilities to post or hand out information that makes it clear that they are not licensed and do not have a licensed medical provider. NIFLA challenged the law as a free speech violation, but the U.S. District Court for Southern California rejected its argument, as did the U.S. Court of Appeals for the Ninth Circuit.

This case was argued before the U.S. Supreme Court on March 20.

Susan will inform us what it is like to be a plaintiff up against one of the most prestigious universities - affecting her career, marriage well-being, and financial security. We will also learn about the critical role the AAUW Legal Fund plays in advancing women's rights and about the AAUW Legacy Fund.

Details Revealed about School Safety Commission

Secretary of Education **Betsy DeVos** appeared before a House Appropriations subcommittee in March at a hearing on the U.S. Department of Education's FY19 budget proposal. During her testimony, Secretary DeVos revealed that the newly-announced federal commission on school safety would be comprised of just four cabinet secretaries: Attorney General **Jeff Sessions**; Secretary of Homeland Security **Kirstjen Nielsen**; Health and Human Services Secretary **Alex Azar** with Secretary DeVos serving as chair. The limited scope of the group has prompted concerns of partisanship and fears that the administration is omitting essential voices from discussions about school safety, including those of parents, teachers, advocates, and subject-matter experts. When pressed about the commission's makeup, DeVos said the group would be "inviting and having forums and meetings with a wide variety of experts."

State Spotlight

Frustrated by the lack of action on a state [sexual harassment bill stuck in committee](#), AAUW of Maryland members used the AAUW Action Network to motivate activists. They urged constituents of committee members to call and ask for a vote to be scheduled before the crossover date, the deadline when bills can no longer pass from one chamber to another. The committee received so many calls that a vote was scheduled and the bill successfully passed out of the House in time to move to the Senate.

AAUW Cheer: Women are making history in Congress. Mississippi Gov. **Phil Bryant** (R) appointed state Commissioner of Agriculture and Commerce **Cindy Hyde-Smith** (R) to the U.S. Senate, making her the first woman from her state to serve in Congress. Hyde-Smith will fill the seat retiring Sen. **Thad Cochran** (R-MS) is vacating on April 1; and at 35 years of service, Rep. **Marcy Kaptur** (D-OH) is now the longest-serving woman in the U.S. House of Representatives. AAUW congratulates Rep. Kaptur and soon-to-be Sen. Hyde-Smith on these milestones!

AAUW Jeer: A survey of more than 65,000 full-time physicians by Doximity found a 27.7 percent gap between men's and women's earnings in the field. This represents a growing pay gap for physicians, as the field's pay gap was 26.5 percent in 2016.

Bits and Pieces:

-- The U.S. Supreme Court denied a request from Republican leaders to block the use of the Pennsylvania Supreme Court's [redrawn congressional map](#). The former district boundaries, established in 2011, had consistently yielded Republican victories in 13 of the 18 congressional districts. The redrawn map is an attempt by the state to correct partisan gerrymandering before the upcoming midterm election.

-- A federal judge blocked a Mississippi law that would implement [the most restrictive ban on women's reproductive rights](#) in the nation. This piece of legislation, signed into law earlier this week, prohibits women from receiving abortions after 15 weeks of pregnancy (down from the 20-week restriction already in place).

-- Rep. **Louise Slaughter** (D-NY) died last month due to injuries sustained in a fall last week. Rep. Slaughter was a trailblazer, valued AAUW ally, and dedicated advocate for women's rights, including supporting Title IX, equal pay, and the Violence Against Women Act throughout her career. We extend our deepest sympathies to her friends and family.
