Navigating the Gender Pay Gap

The gender pay gap is real! Despite recent media attention and incremental improvements, women on average make almost 20% less than men. The pay gap is worse for women of color. For example, African American women earn 63%, and Hispanic women earn 54%. *But we can take action to close the gap faster!* We can: (1) Learn the facts so we can fight back. (2) Ask for more! Learn negotiation skills for increasing our salary and benefits. (3) Support laws that further gender pay equity.

This program will provide key information on this issue and involve participants in negotiations skills exercises.

The fight for Women's Suffrage in the US was long and arduous. Passage of the 19th Amendment on Aug 26, 1920 was an epic achievement, yet the journey was fraught with racism and divisive politics. What allowed the final victory to occur? Why did women's suffrage groups choose strategies that marginalized black women, telling noted black women leaders to "walk in the back of the parade"? Do we still face these hard choices in our strategies to build coalitions and advance causes in today's political world?

Two panelists and a moderator will share the history of this great achievement along with perspectives that will help us make better strategic choices in today's political arena.



Margot McMillen, author of *"The Golden Lane: How Missouri Women Gained the Vote and Changed History"* will speak on: ***What worked to pass the Nineteenth Amendment?*** Lessons learned from successful coalitions in Missouri, including the Golden Lane March in 1916.

Louise Wilkerson, Co-President, League of Women Voters of Metro St. Louis and **Past President**, St. Louis Metropolitan Alumnae Chapter of Delta Sigma Theta Sorority, 2010-2014, will discuss ***What were the hard lessons leading up to and then following in the 100 years since passage?*** Recounting the history of racism & segregation in the suffrage movement, the rise of black women's groups/clubs and the many challenges to voters' rights throughout the decades. How adversaries of equal suffrage find ways to divide us.

Panelists will take questions and then together address the question: *"Can we learn to strategize stronger partnerships through these hard lessons?"*

AAUW METRO ST LOUIS INTER-BRANCH COUNCIL (IBC)

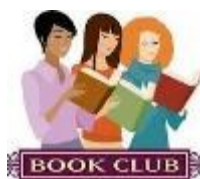

PUBLIC POLICY

The **AAUW 2019–21 Public Policy Priorities** state, “The work of AAUW builds upon responsible public participation, and the following priorities provide a basis for AAUW members' actions in local, state, national, and international levels.”

The Ballwin-Chesterfield Branch is currently involved with the initiative petition to adopt Medicaid expansion. Be sure to sign a petition if you see someone asking for signatures.

Our state legislators returned last month, and SJR 38 is already at the committee hearing level. This legislation would overturn Amendment One, Clean Missouri, which Missouri voters passed in November 2018. This amendment focuses on redistricting and ethics reform. Over 1.4 million Missouri voters passed Amendment One with 62 percent in favor. AAUW Missouri supported passage of this law and wants it protected.

In January 2017, CNN shared 25 Ways to be Politically Active, Whether you Lean Left or Right. The first three items were

- Know your local legislators
- Know how to reach them, and
- Identify an issue you care about.

If you don't know your elected official, go to www.openstates.org. Call or visit them, and tell your elected official to protect our vote on Clean Missouri.

Limiting Our Livelihoods

Have you ever wondered what your AAUW contributions are spent on at the national level? Just this past November, AAUW was the source of an analysis by the Equal Employment Opportunity Commission's (EEOC) data on sexual harassment charges. The article is titled, “Limiting Our Livelihoods: The Cumulative Impact of Sexual Harassment on Women's Careers.” It deduced that workplace sexual harassment is a serious problem for women of all ages, which can have long-term repercussions on their mental health, short- and long-term economic security, and access to leadership positions. Using the EEOC data and the AAUW survey of members and networks, EEOC charges were documented by age, race, and sex, describing the cumulative impact of sexual

harassment over women's lifetimes. The study gave solutions to end workplace harassment for individuals, employers, state policymakers, and Congress. Isn't this what we want for our daughters, granddaughters, nieces, and all working women? Your generous contributions helped make this study possible.

In December, the **Coca-Cola Foundation** awarded AAUW a \$500,000 renewal grant to continue training thousands of women in effective negotiation and leadership skills. We are truly grateful for all the AAUW members who shared our [Work Smart Online tool](#) with audiences around the country. Your work was key to helping us win this new opportunity.

Tell Your Senators: Pass the Paycheck Fairness Act

The House of Representatives passed this important legislation last March, but the Senate has failed to move it forward. On the anniversary of the enactment of the Lilly Ledbetter Fair Pay Act, January 29th, we're calling for action. There is no more fitting way to mark this historic milestone than by making more real, concrete progress in ensuring all women receive fair pay.

Equal pay for equal work is a principle we can all get behind — but we need all senators to show their support for the Paycheck Fairness Act. It's time we put the pressure on! [TAKE ACTION](#)
