#### St. Louis Branch members will be voting to amend the branch bylaws at our annual meeting on May 16.

Currently, our bylaws do not contain a provision for meetings to be held electronically. This article authorizes the ability to hold <u>all</u> meetings electronically. The newly published 2020 12<sup>th</sup> edition of *Robert's Rules of Order* states that electronic meetings must be authorized in the bylaws.

This amendment will be inserted in the bylaws, and the following article will be renumbered. The proposed amendment has been approved by the AAUW MO governance chair. The AAUW St. Louis Branch bylaws can be found on the branch website.

#### **ARTICLE XIV, ELECTRONIC MEETINGS**


Any meeting of the membership, board, executive committee, committees, task forces or other AAUW St. Louis Branch groups may be conducted in whole or part by electronic means as long as all persons participating, whether in person or electronically, may hear each other and communicate in real time. Participation in an electronic meeting constitutes attendance and any official actions shall be recorded in minutes.

According to Article VII. Section 2: Affiliate Amendments:

Provisions of the Affiliate bylaws, not mandated by AAUW, may be amended by a two-thirds vote of members voting after a quorum is attained. Proposed bylaw amendments shall be sent to the entire membership at least 14 days prior to the applicable meeting.

#### Report on the March 20<sup>th</sup> - "Earn What You Deserve: Navigating the Gender Pay Gap Program"

On Saturday, March 20<sup>th</sup>, **Ellen Irons** delivered a 90-minute program on Navigating the Gender Pay Gap to eight participants via Zoom. Five AAUW members attended, including **Jan Scott** and **Diane Sher** from our St. Louis Branch and **Sue Shineman**, AAUW MO state board president. Other AAUW members attended from Ballwin-Chesterfield and the Ferguson-Florissant branches. The program covered key statistics and causes of the gender pay gap and several ways to help close the gap, including what legislation to support. Several hands-on negotiation exercises were done in break-out sessions. Ellen then introduced the group to the online Work Smart program



and played several of the negotiations role-play videos. The Buder Branch Library coordinator, **Jordan Moorhouse**, was very happy with the program, both personally and from the library's point of view. She felt the value of Work Smart was very high and suggested we might return with a full Work Smart program when in person options are available.

We met at their location (2717 Sydney Street, 63104) on Sunday afternoon, April 11th. Our tour guide was none other than Lisa Weingarth, vice president of institutional advancement (formerly with the Women's Foundation of Greater St. Louis).

Rung's mission is to empower women to grow and achieve sustained independence through co-located and coordinated educational, professional, and economic resources. They offer the resources, space, and community for women who are ready to work toward the life they deserve. With several organizations operating under one roof, they offer women a "one-stop-shop" for career and personal growth – all at no cost to their members. To be an eligible candidate for Rung, women must have: Annual income under \$50k, history of stable employment, secure housing, and have the ability to get to the Rung facility in South St. Louis City on a weekly basis.

Their story began on April 17, 2010, when, with the workforce reeling from the economic recession of 2008, Ali Kindle and Mallarie Zimmer opened Rung. Rung began as a retail store to help women and their careers through affordable consignment business clothing. They now have a much larger goal, a beautiful building with impressive designs throughout, and a beautiful website; check it out at <a href="https://rungforwomen.org/">https://rungforwomen.org/</a>.

Lisa said that they are always looking for volunteers; so if you or someone you know is interested in helping, they have at least three ways to do so. Training is required. Rung mentoring partners will engage in a year-long volunteer commit as they serve in the "mentor" role. A mentoring partner will work to aid in the advancement of a Rung member's progress toward meeting career goals by providing advice, feedback, and guidance along their career development journey and help to expand a Rung member's professional network by suggesting and facilitating useful introductions and connections related to the targeted career goals. They can be reached here.

- ⇒ General volunteer—From serving as a greeter at events, helping organize materials on-site, to virtual recruitment efforts, general Rung volunteers will be able to lend a helping hand to many tasks with the manager of Social Capital and Volunteer Programs.
- ⇒ Co-designer volunteer—Volunteers will be able to harvest or build in the garden, read or play in the child watch facility, work as a tutor for school-aged children, serve or clean-up in the café, or assist in checking members into various fitness or wellness classes.
- ⇒ Social capital volunteer—Volunteers will help build networks of relationships among people who live and work in our community. Within Rung's Social Capital Program, there are five components to assist you in the creation of your connections and networks.

#### **Take Action on the Most Pressing Policies**

The House of Representatives voted last month, with bipartisan support, to remove the arbitrary deadline for ratifying the Equal Rights Amendment. It's a huge leap forward toward guaranteeing constitutional

equality between men and women. Now that the Paycheck Fairness Act has passed the House, it joins several AAUW public policy priorities waiting for action in the Senate. These bipartisan bills need your vocal support now more than ever:



**Paycheck Fairness Act** (PFA): AAUW has worked for decades to pass this landmark legislation to advance pay equity, and this is the year it will finally triumph. Demand equal pay for equal work!

**Equal Rights Amendment** (ERA): The historic amendment, which would once and for all ensure constitutional gender equality, was first proposed nearly 100 years ago. Tell your Senators to ratify the ERA now!

**Equality Act**: America's civil rights laws should provide explicit protections against discrimination based on sexual orientation and gender identity. Ensure your Senators know <u>equality means including all people!</u>
