<u>Duct tape</u> is found at many crime scenes. For example, it is used to tie people up, make explosives, and to package drugs. Duct tape is adhesive and is therefore a rich source for forensic findings, such as hairs, other human biological

traces, fingerprints, and fibers. As a consequence, duct tape can play an important role in solving a criminal case.

Jenny Smith, a leading forensic science investigator and a national expert and witness in duct tape investigations and trials, will be the speaker at our third joint monthly meeting with the St. Louis Branch. Jenny is retired with 28 years of experience with the Missouri State High-



way Patrol Crime Lab. She holds a BS in Medical Technology from Central Missouri State University and Menorah Medical Center and a Master of Science degree in Pathology from the University of Missouri, Columbia.



When AAUW began in 1881, few women had the opportunity to pursue a degree—prompting founder Marion Talbot to create and build an organization to advocate for women's education.

The AAUW St. Louis branch affiliate was founded in 1893, the same year as the Kansas City Branch. To-day, women outnumber men in earning degrees at nearly every level. AAUW National is celebrating 144 years, and the St. Louis Branch is in the midst of our 132nd anniversary year!

#### **No Kings Day Event**

There is so much going on in today's world. For me, it is hard to watch or read the news with such bizarre and bewildering behavior our president and leaders take part in. I feel as though I can't complain unless I can help do something about it. At the federal or local level, I see our rights being taken away piece by piece. So on a more local level, I have volunteered to collect signatures for "Respect Missouri Voters." This is a nonpartisan petition, using clearer language, prohibiting changing or repealing laws, and preserves our existing majority vote from these petitions. Missouri is one of out the twenty-four states that allows citizen initiative petitions, which our legislators are trying to take away by raising the threshold to pass these initiatives.

Our kick-off meeting a month ago was a huge success, with hundreds of like-minded, pissed-off but positive folks! Organized chaos at it's finest. Being a newbie, I waited in line, signed up, bought a T-Shirt and sat in the auditorium. Several organizers spoke, and then Ray Hartmann, founder of *Riverfront Times*, spoke. He said, "We are losing our democracy right in front of us. We have to fight for this." Instructions were given to look on the website for events, and the rest was a rah-rah session. I signed up for the No Kings Protest on Oct 18th.

The storm on Capitol Hill and Jefferson City had to fol-

low the "No Kings" day event in St. Louis, literally. It poured on and off all day! I was out there in South County on Lindbergh Blvd with my golf umbrella and hundreds of other like-minded people for two hours. I had to make trips to my car to dry out petitions and protect signatures. It was overwhelming how many



people wanted to sign. How comforting to know that so many people came together to let their voices be heard. Toward the end, I had no voice left, and not until then did I realize that I was soaked to the bone.

This isn't over. It's a continued fight for our democracy. I feel like I'm in a horror movie. And I can't just ignore the news. All is not lost. The take-way is that people are coming together to stand up for what they believe in. The No Kings has a website (nokings.org) and is continuing to organize folks and share what we can do in this fight. They have a card you can print out, Know Your Rights. They suggest handing it to your neighbors who could possibly be deported or even for future protests (it's printed in several different languages). The group Indivisible (Indivisible.org) has organized No Kings Day. They provide other tools to strengthen groups and build power locally. I have to stay positive. I heard the term, "Joyful Warriors." This is what I witnessed on October 18th, 2025, Joyful Warriors!

Jan 22 All the Colors of Dark, by Chris Whitaker, 608 pages, June 2024, Kay Meyer, facilitator. 1975 is a time of change in America. The Vietnam War is ending. Muhammad Ali is fighting Joe Frazier. And in the small town of Monta Clare, Missouri, girls are disappearing. When the daughter of a wealthy family is targeted, the most unlikely hero emerges—Patch, a local boy, who saves the girl, and, in doing so, leaves heartache in his wake. Patch and those who love him soon discover that the line between triumph and tragedy has never been finer. And that their search for answers will lead them to truths that could mean losing one another.

<u>Feb 26</u> Heartland: A Memoir of Working Hard and Being Broke in the Richest Country on Earth, by Sarah Smarsh, 304 pages, 9-18-2018. Lynne Roney, facilitator.

Sarah Smarsh was born a fifth generation Kansas wheat farmer on her paternal side, and the product of generations of teen mothers on her maternal side. Through her experiences growing up on a farm thirty miles west of Wichita, we are given a unique and essential look into the lives of poor and working-class Americans living in the heartland. During Sarah's turbulent childhood in Kansas in the 1980s and 1990s, she enjoyed the freedom of a country childhood but observed the painful challenges of the poverty around her; untreated medical conditions for lack of insurance or consistent care, unsafe job conditions, abusive relationships, and limited resources and information that would provide for the upward mobility that is the American Dream. By telling the story of her life and the lives of the people she loves with clarity and precision but without judgement, Smarsh challenges us to look more closely at the class divide in our country. Beautifully written, in a distinctive voice, Heartland combines personal narrative with powerful analysis and cultural commentary, challenging the myths about people thought to be less because they earn less.

They grow up together sharing their secrets, dreams and happiness. Then Sula breaks free from their small-town community in the uplands of Ohio to roam the cities of America. When she returns ten years later much has changed. Including Nel, who now has a husband and three children. The friendship between the two women becomes strained and the whole town grows wary as Sula continues in her wayward, vagabond and uncompromising ways.



#### **Public Policy**

Three important issues involving major changes are presently in the process of being brought to the voters of Missouri sometime in 2026.



The first involves Missouri's eight congressional districts, **which were altered during the special legislative session** in September. The districts were redrawn to favor seven Republican-leaning districts and one thought to be Democratic. This reduces the Democratic-leaning districts from two to one. Several lawsuits have been filed to



challenge this map. There is also a Referendum Petition to put the map to a vote of the people. A group named People Not Politicians is circulating a petition to support this cause, which the **AAUW Missouri state board endorses.** There needs to be approximately106,000 signatures (by December 11) to get this on the ballot. At the end of October, Missouri Attorney General Catherine Hanaway filed a lawsuit against the petition, arguing that nothing in the Missouri Constitution "expressly says that federal congressional reapportionment may be subjected to a referendum." Hanaway believes allowing a referendum on the map "will invite chaos."

Another issue of concern is **HJR 3 Amendment 4**, which changes the **Initiative petition process** that has been in the Missouri Constitution for one hundred years. It would effectively take away the people's right to one person, one vote. A petition by the group Respect MO Voters is circulating about this bill. The AAUW MO State Board has not endorsed this petition.

The final issue is Amendment 3 which relates to reproductive rights. The Legislature has passed a new amendment with the same amendment number that will nullify the previous Amendment 3. The new amendment will reduce the protection currently existing in the Missouri Constitution. Continue to look for updates on these critical issues.

#### A Current Clinic Grant Awardee:

<u>Civil Rights & Housing Clinic, University at Buffalo School of Law</u>

The Civil Rights and Transparency Clinic is a litigation clinic focused on civil rights and civil liberties, spanning constitutional liberties like free speech, privacy, due process, and statutory civil rights against discrimination.

Their Cases: These cases are representative of the clinic's docket.

- Successful appeal to the Fourth Department Appellate Division to overturn a trial court ruling in a housing voucher discrimination case.
- Defending tenants facing eviction in Buffalo City Court.
- A public comment letter to the U.S. Department of Housing and Urban Development (HUD) in support of a proposed rule to reduce housing segregation.
- Litigation to enforce freedom of information requests, such as requests for the government to release accurate statistics on suicides in local jails.
- Legal name change petitions for transgender clients.
